

U.S. Department of Labor, Employee Retirement Income Security Act (ERISA) Filing Acceptance System II (EFAST2)

Jazz Solutions, Inc. (JSL) is a subcontractor to General Dynamics Information Technology, a leading system integrator on the EFAST2 contract. The EFAST2 system provides a 100% web-based system to support the critical business process of filing, processing, and making available the ERISA filings. The 1.1 million ERISA filings submitted annually allow the DOL's Employee Benefits Security Administration, Internal Revenue Service, and Pension Benefit Guaranty Corporation to exercise the oversight necessary to protect the pension and benefit plans that cover 150 million eligible employees and their dependents, and report on assets of approximately \$6 trillion. The EFAST2 system provides an electronic filing platform to accept ERISA filings, a web-based software solution to produce and submit ERISA filings, a reporting and disclosure platform, and a Customer Relationship Management (CRM) platform. When EFAST2 went live, we transitioned a 100% paper filing process into a 100% electronic filing process.

JSL provides development and O&M services for the EFAST2 environment, including infrastructure (in FedRAMP AWS Cloud), operating systems, COTS products, and custom code. The EFAST2 system leverages a combination of containerized Docker components deployed to Amazon Elastic Container Service (ECS), serverless Lambda components, a number of other cloud-native AWS services, and IBM middleware products. We also leverage Salesforce as an integrated CRM platform and New Relic for Application Performance Monitoring (APM). JSL provides architecture, design, development, and maintenance services for all those components.

JSL provides support for **application integration** between components of the EFAST2 system, as well as for the customer and partner agencies. This includes IBM Integration Bus, DataPower, AWS API Gateway, and AWS Elastic Load Balancers. In addition, **JSL provides 24x7 operations and production support for the entire environment**, including the EFAST system itself, as well as the products and tools related to delivery of the contract.



Federal Student Aid (FSA) Federal Taxpayer Information Module Services

As a result of the passage and signing of the Fostering Undergraduate Talent by Unlocking Resources for Education (FUTURE) Act, FSA gained access to Federal Tax Information (FTI) from the Internal Revenue Service (IRS). The handling and processing of FTI data requires the implementation of special security controls outlined in IRS Publication 1075. In order to minimize the impact of those security controls, FSA and JSL reached a strategic business and technical decision to reduce the footprint of FTI data by centralizing all FTI (and all system and user interactions involving FTI) within a small, targeted set of FSA systems. To implement this solution, FSA needed to build a solution that includes multiple subsystems that could be implemented in a new FTI infrastructure. Any FSA systems that currently receive, use, store, or transmit taxpayer data would need to implement changes to their impacted business processes to interact with the new FTI module solution. Using an Agile approach to the entire system lifecycle, JSL is delivering a modern solution that implements and integrates dozens of technologies, platforms, and development tools. The FTI Module operates in an AWS GovCloud environment, using serverless computing, Docker containers, and Linux-based EC2 instances.
