Federal Student Aid (FSA) Person Authentication Service (PAS) and Access & Identity Management System (AIMS)

JSL's PAS & AIMS Systems support **100+ million users and 2+ million authentications**. JSL has evaluated all risk vectors, including in-place controls, to ensure both solutions meet NIST SP 800-137 and OMB's A-123 App. A requirements for the last 7 years. PAS & AIMS meet the requirements of a FISMA High System with a full suite of inherited, inheritable, and system-implemented security controls, which are described in JSL's comprehensive system security documentation.

FSA Federal Taxpayer Information Module Services

JSL led the secure integration of critical IRS tax data within the Federal Student Aid systems. The team created a security system that incorporates the high-water mark of IRS PUB 1075, NIST 800-53 Rev. 5, and the FedRAMP moderate baseline. This project obtained the Education Department's Authorization to Operate (ATO) on the first submittal, assuring FSA and the IRS that JSL's solution met or exceeded the latest security standards.
