Miner Health Matters

Mine Safety & Health Administration (MSHA)

JSL led MSHA's Miner Vaccination Outreach Program (MVOP), organizing vaccination clinics, expanding offerings to include test kits and flu shots, and increasing educational outreach through virtual and in-person formats.
